Quantamental Technologies LLC bought a new position in Ecopetrol during the fourth quarter valued at \$64,000. Finally, Quadrant Capital Group LLC lifted its position in Ecopetrol by 117.9% during the fourth quarter. Quadrant Capital Group LLC now owns 5,908 shares of the oil and gas company's stock valued at \$90,000 after purchasing an additional 3,197 shares during the last quarter.

The firm has a market cap of \$43.83 billion, a price-to-earnings ratio of 12.07, a priceto-earnings-growth ratio of 0.70 and a beta of 1.57

> Ecopetrol (NYSE:EC) last released its earnings results on Friday, April 5th. The oil and gas company reported \$0.38 earnings per share (EPS) for the quarter. The firm had revenue of \$6.02 billion during the quarter. Ecopetrol had a net margin of 16.70% and a return on equity of

21.37%. Research analysts anticipate that Ecopetrol SA will post 1.77 EPS for the current fiscal year.

The company also recently announced a special dividend, which will be paid on Friday, May 3rd. Stockholders of record on Wednesday, April 24th will be issued a \$0.3595 dividend. The ex-dividend date is Tuesday, April 23rd. This represents a dividend yield of 2.95%. Ecopetrol's dividend payout ratio (DPR) is presently 35.06%.
