

As Ecopetrol S A Sponsored Ads (EC) Stock Price Rose, Shareholder Pinebridge Investments LP Has Cut Its Position; Rwc Asset Management Llp Position in Paccar (PCAR) Has Increased by \$20.61 Million as Stock Value Rose

Pinebridge Investments Lp decreased its stake in Ecopetrol S A Sponsored Ads (EC) by 44.7% based on its latest 2018Q4 regulatory filing with the SEC. Pinebridge Investments Lp sold 35,954 shares as the company's stock rose 9.48% with the market. The hedge fund held 44,478 shares of the oil & gas production company at the end of 2018Q4, valued at \$706,000, down from 80,432 at the end of the previous reported quarter. Pinebridge Investments Lp who had been investing in Ecopetrol S A Sponsored Ads for a number of months, seems to be less bullish on the \$798.49B market cap company. The stock increased 0.28% or \$0.05 during the last trading session, reaching \$19.42. About 1.03M shares traded or 15.44% up from the average. Ecopetrol S.A. Rwc Asset Management Llp bought 361,573 shares as the company's stock rose 12.68% with the market. The institutional investor held 867,567 shares of the auto manufacturing company at the end of 2018Q4, valued at \$49.57 million, up from 505,994 at the end of the previous reported quarter. Rwc Asset Management Llp who had been investing in Paccar Inc for a number of months, seems to be bullish on the \$24.69B market cap company. The stock increased 0.07% or \$0.05 during the last trading session, reaching \$71.18. About 1.17 million shares traded. 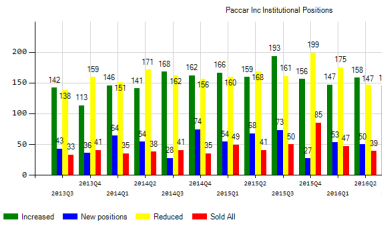
