Engelhard Corp (NYSE:EC) institutional sentiment decreased to 0.76 in 2018 Q4. Its down -1.20, from 1.96 in 2018Q3. The ratio has worsened, as 59 investment professionals increased or started new holdings, while 78 sold and reduced holdings in Engelhard Corp. The investment professionals in our partner's database now possess: 59.40 million shares, up from 56.03 million shares in 2018Q3. Also, the number of investment professionals holding Engelhard Corp in their top 10 holdings decreased from 2 to 0 for a decrease of 2. Sold All: 24 Reduced: 54 Increased: 37 New Position: 22.

Ecopetrol S.A. operates as an integrated oil company. The company has market cap of \$775.46 billion. It operates through three divisions: Exploration and Production; Transport and Logistics; and Refining, Petrochemical and Biofuels. It has a 8.81 P/E ratio. The firm produces crude gas and oil; and engages in the extraction, collection, treatment, storage and pumping, or compression of hydrocarbons.

The stock decreased 0.05% or \$0.01 during the last trading session, reaching \$18.86. About 84,048 shares traded. **Ecopetrol S.A. (NYSE:EC)** has risen 20.53% since April 25, 2018 and is uptrending. It has outperformed by 16.16% the S&P500.

Dorsey Wright & Associates holds 1.48% of its portfolio in **Ecopetrol S.A.** for 312,539 shares. Acadian Asset Management Llc owns 14.02 million shares or 1.1% of their US portfolio. Moreover, Ashmore Group Plc has 0.99% invested in the company for 125,000 shares. The Nevada-based Navellier & Associates Inc has invested 0.72% in the stock. Cypress Capital Management Llc (Wy), a Wyoming-based fund reported 7,965 shares.

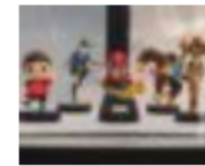

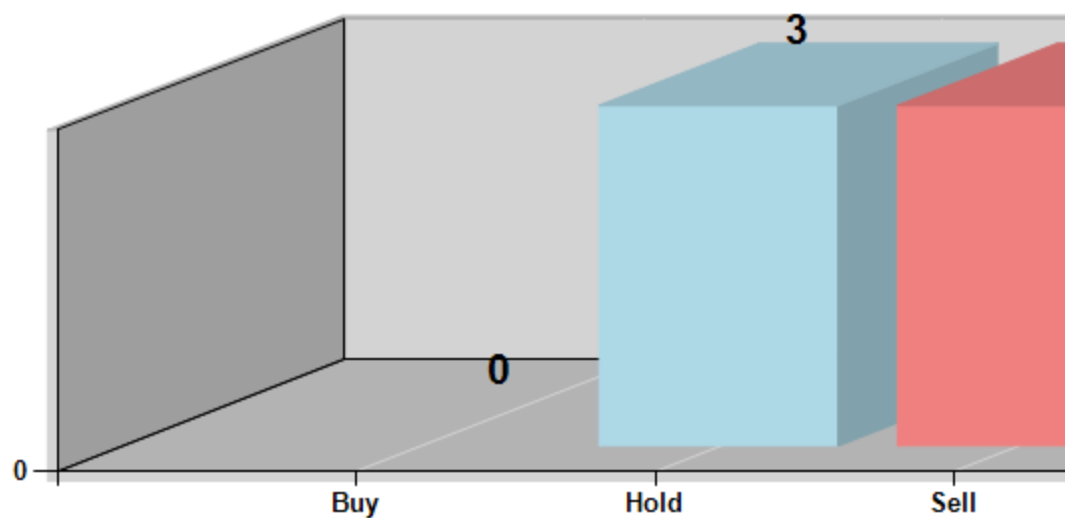
