Ecopetrol SA (EC) Shares Sold by Barrow Hanley Mewhinney & Strauss LLC

Barrow Hanley Mewhinney & Strauss LLC lowered its position in Ecopetrol SA (NYSE:EC) by 0.6% in the 4th quarter, according to its most recent disclosure with the Securities and Exchange Commission (SEC). The firm owned 5,275,121 shares of the oil and gas company's stock after selling 29,911 shares during the period. Barrow Hanley Mewhinney & Strauss LLC owned about 0.26% of Ecopetrol worth \$83,769,000 at the end of the most recent reporting period.

Several other institutional investors and hedge funds have also recently modified their holdings of the stock. Wetherby Asset Management Inc. grew its holdings in shares of Ecopetrol by 3.0% in the fourth quarter. Wetherby Asset Management Inc. now owns 22,344 shares of the oil and gas company's stock worth \$355,000 after acquiring an additional 643 shares during the period. FDx Advisors Inc. grew its holdings in shares of Ecopetrol by 10.1% in the fourth quarter. FDx Advisors Inc. now owns 12,060 shares of the oil and gas company's stock worth \$192,000 after acquiring an additional 1,110 shares during the period. Comerica Bank grew its holdings in shares of Ecopetrol by 1.2% in the fourth quarter. Comerica Bank now owns 120,025 shares of the oil and gas company's stock worth \$2,164,000 after acquiring an additional 1,367 shares during the period. Enlightenment Research LLC bought a new stake in shares of Ecopetrol in the fourth quarter worth \$27,000. Finally, Financial Gravity Companies Inc. bought a new stake in shares of Ecopetrol in the fourth quarter worth \$36,000. 3.05% of the stock is owned by institutional investors.

Several analysts recently commented on the company. Santander raised Ecopetrol from an "underperform" rating to a "hold" rating in a report on Wednesday, March 6th. **Zacks Investment Research** upgraded Ecopetrol from a "strong sell" rating to a "hold" rating in a research report on Friday, February 15th. **ValuEngine** upgraded Ecopetrol from a "sell" rating to a "hold" rating in a research report on Monday, February 4th. Citigroup set a \$21.00 target price on Ecopetrol and gave the company a "hold" rating in a research report on Monday, December 17th. Finally, UBS Group upgraded Ecopetrol from a "sell" rating to a "neutral" rating in a research report on Wednesday, December 12th. Seven investment analysts have rated the stock with a hold rating. The stock has an average rating of "Hold" and a consensus price target of \$25.00.

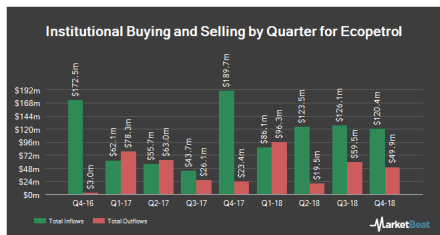
