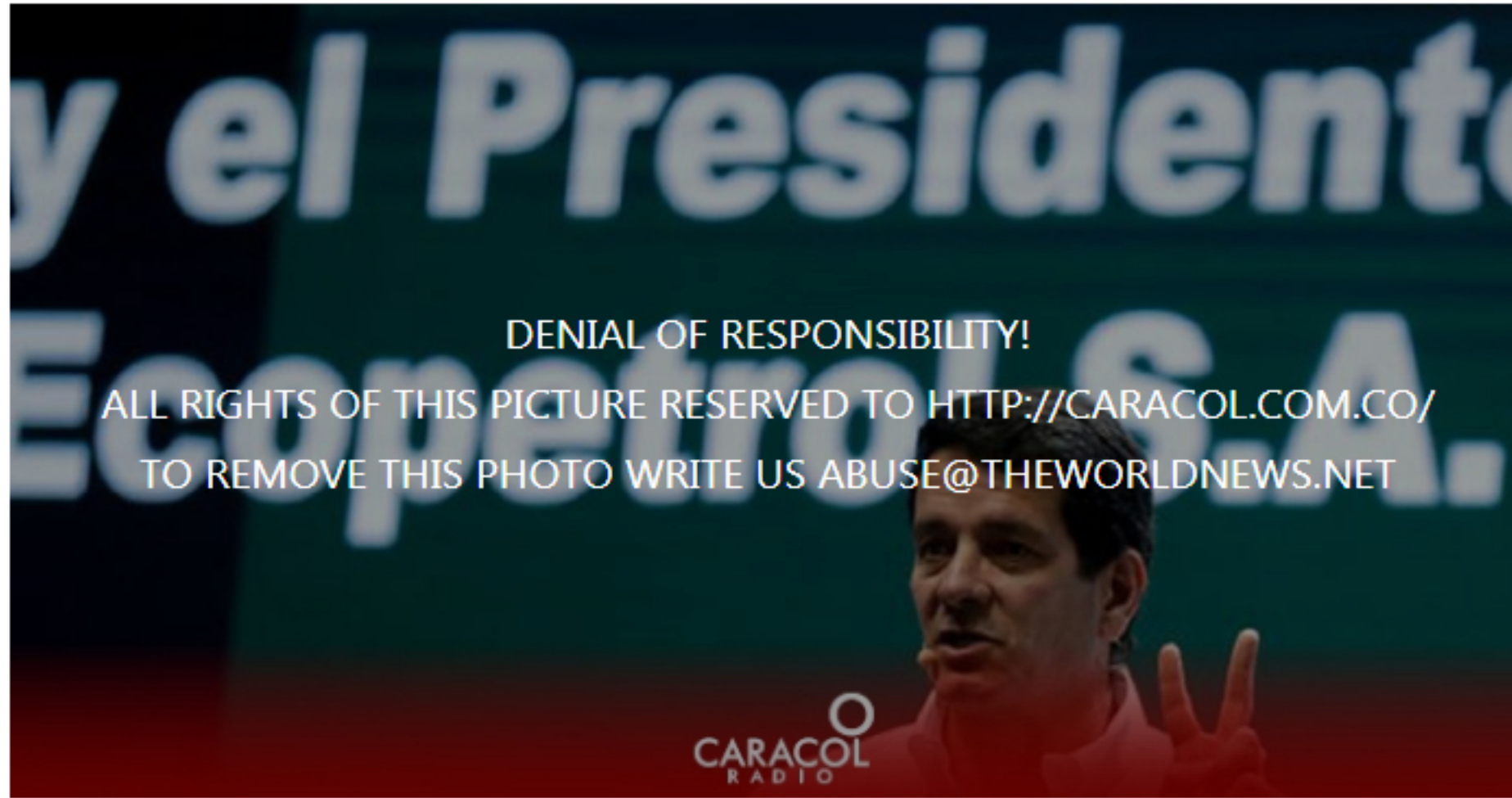

Ecopetrol informa que presentó una oferta vinculante al Ministerio de Hacienda y Crédito Público para la adquisición de su participación mayoritaria en ISA Ecopetrol S.A

La Compañía confirmó, que Junta Directiva en sesión del viernes 30 de julio de 2021, autorizó al Representante Legal de la Compañía para presentar una oferta vinculante al Ministerio de Hacienda y Crédito Público para adquirir el 51.4% de las acciones en circulación de Interconexión Eléctrica S.A. E.S.P – ISA.

Afirmó Ecopetrol, que la oferta oferta se presentó el mismo viernes 30 de julio, dentro de los términos aprobados por la Junta Directiva.
