

Acadian Asset Management LLC Increased Stake in **Ecopetrol S A (EC)** by \$46.70 Million; Shares Rose

During Q4 2018 the big money sentiment decreased to 0.76. That's change of 1.20, from 2018Q3's 1.96. 24 investors sold all, 54 reduced holdings as EC ratio fall. 37 grew stakes while 22 funds amassed stakes. Funds hold 59.40 million shares thus 6.01% more from 2018Q3's 56.03 million shares. Wells Fargo Commerce Mn reported 46,547 shs or 0% of all its holdings. Barrow Hanley Mewhinney Strauss Limited, a Texas-based fund reported 5.28 million shs. Glenmede Tru Na has invested 0% in **Ecopetrol S A. (NYSE:EC)**. Prudential Fin Incorporated reported 24,310 shs stake. Art Advsrs Ltd holds 75,697 shs or 0.08% of its capital. Northern Tru has 237,111 shs.

State Of New Jersey Common Pension Fund D owns 83,300 shs. Suntrust Banks has invested 0% of its capital in **Ecopetrol S A. (NYSE:EC)**. Principal Inc invested 0% of its capital in **Ecopetrol S A. (NYSE:EC)**. Axa accumulated 16,500 shs. Pinebridge Limited Partnership accumulated 44,478 shs. Guggenheim Cap Lc reported 27,285 shs or 0% of all its holdings. Navellier Associate holds 0.72% or 265,386 shs. Macquarie Gp Limited reported 47,064 shs or 0% of all its holdings. Millennium Lc owns 475,261 shs or 0.01% of their US capital.

Acadian Asset Management Llc increased its holdings by 28.55% in **Ecopetrol S A (EC)**, according to 2018Q4 SEC filing. 3.11 million shares were bought by Acadian Asset Management Llc as the company's stock rose 9.48% with the market. The institutional investor is holding 14.02M shares, compared to the 10.90M from the previous quarter. And the reported value of the oil & gas production company is \$222.57M for the 2018Q4. **Ecopetrol S A** has \$873.32 billion market cap. Ticker's shares touched \$21.24 during the last trading session after 2.84% change. Currently **Ecopetrol S.A.** is uprending after 20.53% change in last April 11, 2018. EC has also 667,449 shares volume. The stock outperformed the S&P500 by 16.16%.

The Acadian Asset Management Llc's stake in Salesforce Com Inc (NYSE:CRM) was reduced by 106,322 shares to 6,870 shares valued at \$941,000 in 2018Q4, according to the filing. It manages about \$65.15B and \$20.19 billion US Long portfolio. Acadian Asset Management Llc has cut its stake in Medpace Hldgs Inc and also reduced its holding in Rosetta Stone Inc (NYSE:RST) by 191,576 shares in the quarter, for a total of 23,634 shares.

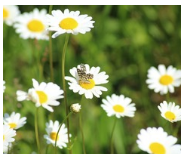

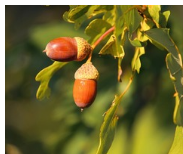
