Ecopetrol S.A. (NYSE:EC) Position Increased by Crossmark Global Holdings Inc.

Crossmark Global Holdings Inc. raised its position in shares of Ecopetrol S.A. (NYSE:EC - Get Rating) by 10.1% in the first quarter, according to its most recent disclosure with the Securities and Exchange Commission. The institutional investor owned 23,896 shares of the oil and gas company's stock after buying an additional 2,195 shares during the quarter. Crossmark Global Holdings Inc.'s holdings in Ecopetrol were worth \$444,000 at the end of the most recent quarter.

A number of other hedge funds also recently bought and sold shares of EC. Barrow Hanley Mewhinney & Strauss LLC lifted its position in shares of Ecopetrol by 16.8% in the fourth quarter. Barrow Hanley Mewhinney & Strauss LLC now owns 3,526,569 shares of the oil and gas company's stock worth \$45,457,000 after purchasing an additional 506,857 shares in the last quarter. JPMorgan Chase & Co. lifted its position in shares of Ecopetrol by 35.0% in the first quarter. JPMorgan Chase & Co. now owns 1,594,087 shares of the oil and gas company's stock worth \$29,651,000 after purchasing an additional 413,021 shares in the last quarter. Fisher Asset Management LLC lifted its position in shares of Ecopetrol by 71.9% in the first quarter. Fisher Asset Management LLC now owns 1,578,099 shares of the oil and gas company's stock worth \$29,353,000 after purchasing an additional 660,298 shares in the last quarter. Itau Unibanco Holding S.A. purchased a new stake in shares of Ecopetrol in the fourth quarter worth approximately \$9,986,000. Finally, Mirae Asset Global Investments Co. Ltd. lifted its position in shares of Ecopetrol by 7.4% in the fourth quarter. Mirae Asset Global Investments Co. Ltd. now owns 403,977 shares of the oil and gas company's stock worth \$5,208,000 after purchasing an additional 27,909 shares in the last quarter. 1.44% of the stock is owned by hedge funds and other institutional investors.

NYSE:EC opened at \$10.31 on Thursday. The stock's 50 day moving average price is \$10.52 and its 200 day moving average price is \$14.50. Analyst Ratings Changes

Separately, TheStreet downgraded [Ecopetrol](#) from a "b-" rating to a "c" rating in a report on Tuesday, July 5th. One analyst has rated the stock with a sell rating and three have given a hold rating to the company's stock. According to MarketBeat, the stock has a consensus rating of "Hold" and a consensus target price of \$15.60.

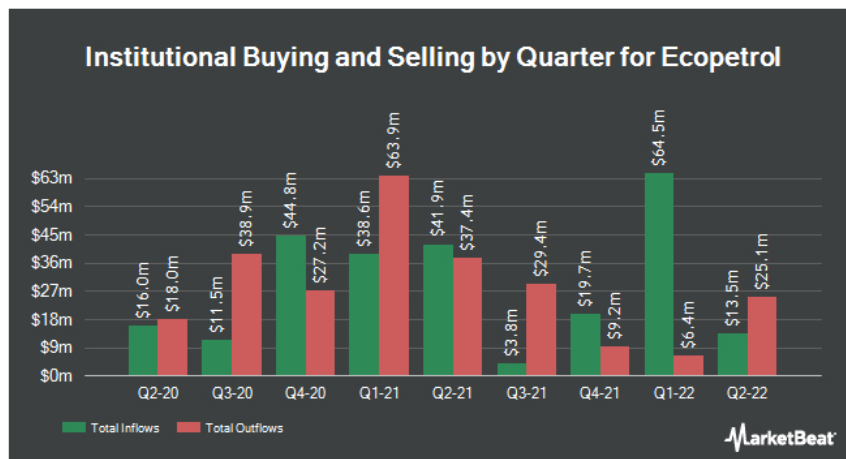
