

"I am very calm": Ricardo Roa

How did the appointment of Néstor Ferney Pérez as manager of Trecsa in 2015 happen?

This standard selection process was done by the GEB Human Resources area. The selection was made by a special officer in the executive search, who examined the work experience of the candidate, with the required requirements, and developed the hiring profile. The announcement was made by the Trecsa Board of Directors. Before this process, I did not know Mr. Pérez.

(In context: The episode that corrupts the strongest candidate for the presidency of Ecopetrol).

Why, when the audit revealed the irregularities committed by Mr. Pérez, was the Office of the Prosecutor notified of these serious findings?

Some of the facts came to light through an anonymous complaint that was brought to an internal hearing, which took an investigation directed at me. Having accepted the resignation, an extraordinary Board of Directors was called, which analyzed the matter, listening to the explanations of Mr. Perezius, who accepted the resignation. At the end of the Congress, we ordered the law district to carry out a detailed investigation, in order to receive possible actions against Mr. Pérez.

President of the board of directors, what ways have you given to recover the money that Mr. Néstor Ferney Pérez had cheated? Are you forced to pay back the money you lost? Was there finally any agreement about his departure?

It does not agree with Mr. Pérez that his departure has been reached. In the said session, the Board of Directors ordered the following actions: 1) Deduct from the liquidation of Mr. Pérez all the expenses that he had wrongfully incurred for the abusive use of the Trecsa group. 2) Undo those decisions related to the salary authorized by the Board of Directors that do not increase and terminate the lease contract with which the highend vehicles of the company's executives were acquired, and 3) Order the legal area of the Company to investigate these facts. If there is room for a complaint before the corresponding judicial authorities.

I do not know of any evidence in which Mr. Pérez is grateful for his merits. Recently I learned that the certification signed by the legal representative of Trecsa where I thank you that I do not share and because of that I do not know why it appears in that document.

Why did you report this to the Prosecutor's Office despite the fact that the charges were clearly established? The complaint for which Mr. Pérez ended up convicted was filed by the administration of Astrid Álvarez, his successor, on March 2, 2016, when he had already left the company.

As I have already indicated what I did I was ordered in the legal area to find out the situation, if there was room for complaints. I understand that this investigation could be the basis of the complaints that were later proposed and led to the conviction of Mr. Pérez.

Did you travel to Indianapolis (United States) where you met Mr. Néstor Ferney Pérez when he was still the manager of Trecsa? What was the reason for that trip? Who invited them?

So I went to the USA to see Juan Pablo Montoya's race. I did it with my resources and private time. I was invited to the office of the father of another of the brokers, where Mr. Pérez was, who worked at Trecsa. This happened in May 2015 before anything was known about his reprehensible actions.

Have you been or are you a friend of Mr. Néstor Pérez? Are you still in touch? Did you know that the man was sentenced by Colombian justice?

I was never friends with Mr. Pérez. The last time I saw him was when we received his resignation. Of course I know the convict, he confessed and admitted the charges.

You are being investigated by the prosecutor for these actions. What is the legal status of this case?

The prosecutor's office called me in that investigation to clarify the facts and of course they found no participation or responsibility in them. Lacted as prosecutor in my capacity as chairman of Trecsa's board of directors at the time of the events, they listened to me and did not bind me to the process.

According to highly informed sources, you will be the next president of **Ecopetrol**. Do you think that the investigation carried out today by the National Electoral Council for the alleged violation of the caps in the recent presidential campaign and this event Trecsa in Guatemala could affect your constitution? Do you feel silence on both fronts?

The CNE did not open an investigation against the war or the person of Richard Roa. The order to open a preliminary investigation requires, among other things, the National Registry to send the registration and registration forms of the candidates to the campaign and to the CNE campaign financing fund, the receipt and expenditure forms of the campaign from which it had heard, reasons It is surprising that within the scope of ecopetroleum research, the events that resurrected Trecsa, have already been resolved for more than six years by the courts with the clear purpose of reducing my fame, reputation and professional life. Mexico City. – From Acapulco, Guerrero, the foreign minister, Marcelo Ebrard Casaubon, requested that Morena already call for the registration of candidates for the 2024 presidential candidate, so that people know who they are and what they propose.


