**ECOPETROL S.A. (NYSE:EC) SHARES SOLD BY TIDAL INVESTMENTS LLC**

Tidal Investments LLC cut its holdings in shares of [Ecopetrol](#) S.A. (NYSE:EC – [Free Report](#)) by 11.1% during the first quarter, according to the company in its most recent Form 13F filing with the Securities and Exchange Commission. The fund owned 59,365 shares of the oil and gas company's stock after selling 7,405 shares during the period. Tidal Investments LLC's holdings in [Ecopetrol](#) were worth \$703,000 at the end of the most recent reporting period.

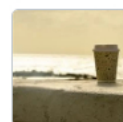
A number of other institutional investors have also modified their holdings of the business. Vanguard Group Inc. increased its position in [Ecopetrol](#) by 1.0% in the 3rd quarter. Vanguard Group Inc. now owns 3,086,272 shares of the oil and gas company's stock valued at \$35,739,000 after acquiring an additional 29,731 shares during the period. New York State Common Retirement Fund purchased a new stake in shares of [Ecopetrol](#) during the fourth quarter worth approximately \$781,000. GAMMA Investing LLC acquired a new stake in shares of [Ecopetrol](#) during the fourth quarter worth \$85,000. Glenorchy Capital Ltd acquired a new position in [Ecopetrol](#) in the 4th quarter valued at \$338,000. Finally, Anfield Capital Management LLC raised its position in [Ecopetrol](#) by 18.7% during the 4th quarter. Anfield Capital Management LLC now owns 18,949 shares of the oil and gas company's stock worth \$226,000 after buying an additional 2,982 shares during the last quarter.

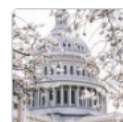

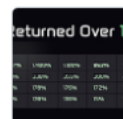

quick ratio of 1.34 and a debt-to-equity ratio of 0.90. The firm has a market capitalization of \$20.63 billion, a P/E ratio of 4.36 and a beta of 1.23. The firm's 50-day moving average is \$11.32 and its two-hundred day moving average is \$11.54.

[Ecopetrol](#) (NYSE:EC – [Get Free Report](#)) last released its quarterly earnings results on Wednesday, May 8th. The oil and gas company reported \$0.50 earnings per share for the quarter, missing analysts' consensus estimates of \$0.59 by (\$0.09). [Ecopetrol](#) had a return on equity of 8.82% and a net margin of 14.35%. The firm had revenue of \$7.98 billion during the quarter, compared to analyst estimates of \$8.19 billion. On average, research analysts predict that [Ecopetrol](#) S.A. will post 2.41 earnings per share for the current fiscal year.

### WALL STREET ANALYST WEIGH IN

Several analysts have recently weighed in on EC shares. [StockNews.com](#) downgraded shares of [Ecopetrol](#) from a "buy" rating to a "hold" rating in a report on Tuesday, July 30th. Bank of America cut [Ecopetrol](#) from a "neutral" rating to an "underperform" rating in a research report on Thursday, May 30th. Finally, The Goldman Sachs Group raised their price target on [Ecopetrol](#) from \$10.30 to \$11.90 and gave the company a "neutral" rating in a report on Thursday, April 18th. Three analysts have rated the stock with a sell rating and four have given a hold rating to the company's stock. According to data from MarketBeat, the company presently has a consensus rating of "Hold" and an average price target of \$11.27.

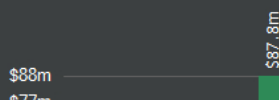

The company operates through four segments: Exploration and Production; Transport and Logistics; Refining, Petrochemical and Biofuels; and Electric Power Transmission and Toll Roads Concessions. It engages in the exploration and production of oil and gas; transportation of crude oil, motor fuels, fuel oil, and other refined products, including diesel, jet, and biofuels; processing and refining crude oil; distribution of natural gas and LPG; sale of refined and petrochemical products; supplying of electric power transmission services; design, development, construction, operation, and maintenance of road and energy infrastructure projects; and supplying of information technology and telecommunications services.

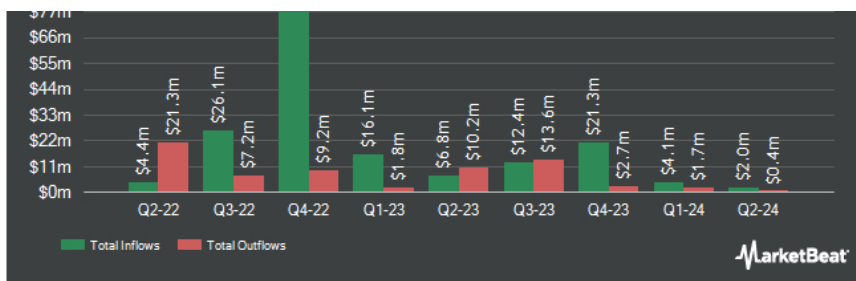
