Jump Financial LLC cut its stake in [Ecopetrol S.A. \(NYSE:EC - Free Report\)](#) by 94.1% during the third quarter, according to its most recent disclosure with the Securities and Exchange Commission. The fund owned 14,742 shares of the oil and gas company's stock after selling 236,223 shares during the quarter. Jump Financial LLC's holdings in [Ecopetrol](#) were worth \$171,000 as of its most recent filing with the Securities and Exchange Commission.

Other hedge funds have also modified their holdings of the company. Robeco Institutional Asset Management B.V. increased its position in [Ecopetrol](#) by 37.8% during the third quarter. Robeco Institutional Asset Management B.V. now owns 490,047 shares of the oil and gas company's stock worth \$5,675,000 after buying an additional 134,531 shares during the last quarter. Private Advisor Group LLC acquired a new position in [Ecopetrol](#) during the second quarter worth \$142,000. Morningstar Investment Management LLC acquired a new position in [Ecopetrol](#) during the second quarter worth \$176,000. Acadian Asset Management LLC acquired a new position in [Ecopetrol](#) during the second quarter worth \$34,000. Finally, Campbell & CO Investment Adviser LLC bought a new stake in [Ecopetrol](#) during the second quarter valued at about \$176,000. 1.29% of the stock is owned by institutional investors and hedge funds.

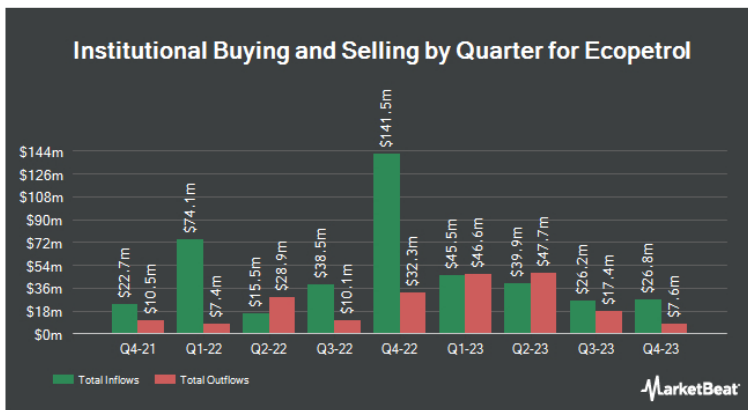
