## ECOPETROL STOCK PERFORMANCE

EC opened at \$11.04 on Friday. [Ecopetrol](#) S.A. has a fifty-two week low of \$8.59 and a fifty-two week high of \$13.14. The company has a current ratio of 1.47, a quick ratio of 1.24 and a debt-to-equity ratio of 0.90. The firm's fifty day moving average price is \$11.64 and its two-hundred day moving average price is \$11.95.

## WALL STREET ANALYSTS FORECAST GROWTH

Several equities research analysts have recently issued reports on EC shares. Morgan Stanley downgraded shares of [Ecopetrol](#) from an "equal weight" rating to an "underweight" rating and lowered their price objective for the stock from \$11.00 to \$8.50 in a research note on Monday, March 4th. JPMorgan Chase & Co. decreased their price target on shares of [Ecopetrol](#) from \$12.50 to \$12.00 and set a "neutral" rating on the stock in a research note on Tuesday, February 20th. Two research analysts have rated the stock with a sell rating and five have assigned a hold rating to the stock. According to data from MarketBeat, the stock presently has a consensus rating of "Hold" and a consensus target price of \$11.60.

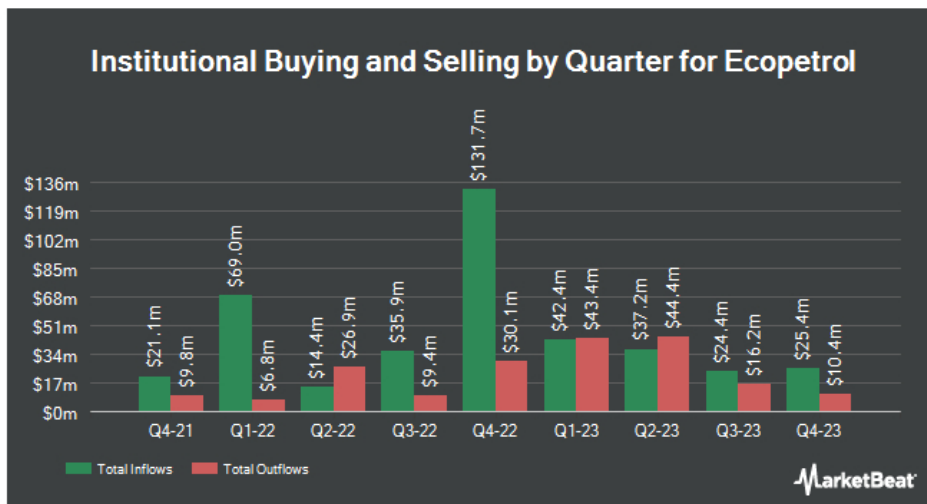

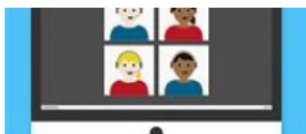

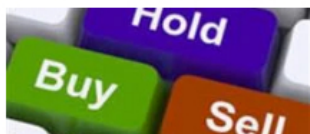
