Fitch Ratings Downgrades Ecopetrol's Global Rating Following Sovereign Cut

Ecopetrol S.A. (BVC: **ECOPETROL**; NYSE: EC) ("**Ecopetrol**" or the "Company") announces that credit rating agency Fitch Ratings has downgraded the Company's global rating from BB+ to BB with a Stable Outlook, in line with the adjustment made to Colombia's sovereign rating on December 16, which was also lowered to BB with a Stable Outlook. This change reflects the strong link between **Ecopetrol** and Colombia.

The agency has maintained **Ecopetrol**'s Standalone Credit Profile (SACP) at 'bbb-', within investment grade, highlighting the Company's strategic importance as the country's leading hydrocarbon producer.

Ecopetrol is the largest company in Colombia and one of the main integrated energy companies in the American continent, with more than 19,000 employees. In Colombia, it is responsible for more than 60% of the hydrocarbon production of most transportation, logistics, and hydrocarbon refining systems, and it holds leading positions in the petrochemicals and gas distribution segments. With the acquisition of 51.4% of ISA's shares, the company participates in energy transmission, the management of real-time systems (XM), and the Barranquilla - Cartagena coastal highway concession. At the international level, **Ecopetrol** has a stake in strategic basins in the American continent, with Drilling and Exploration operations in the United States (Permian basin and the Gulf of Mexico), Brazil, and Mexico, and, through ISA and its subsidiaries, **Ecopetrol** holds leading positions in the power transmission business in Brazil, Chile, Peru, and Bolivia, road concessions in Chile, and the telecommunications sector.
