STATE STREET CORP SELLS 43,029 SHARES OF **ECOPETROL** S.A. (NYSE:EC)

State Street Corp trimmed its position in **Ecopetrol** S.A. (NYSE:EC – [Free Report](#)) by 13.7% during the third quarter, according to the company in its most recent Form 13F filing with the Securities and Exchange Commission. The institutional investor owned 271,215 shares of the oil and gas company's stock after selling 43,029 shares during the quarter. State Street Corp's holdings in **Ecopetrol** were worth \$2,422,000 at the end of the most recent quarter.

A number of other large investors also recently modified their holdings of EC. Blue Trust Inc. grew its position in **Ecopetrol** by 135.5% during the third quarter. Blue Trust Inc. now owns 6,352 shares of the oil and gas company's stock worth \$57,000 after buying an additional 3,655 shares in the last quarter. Straight Path Wealth Management boosted its position in shares of **Ecopetrol** by 7.4% during the 2nd quarter. Straight Path Wealth Management now owns 14,600 shares of the oil and gas company's stock valued at \$163,000 after acquiring an additional 1,000 shares during the last quarter. Rathbones Group PLC bought a new stake in shares of **Ecopetrol** during the 2nd quarter valued at about \$172,000. Aigen Investment Management LP purchased a new position in shares of **Ecopetrol** during the third quarter worth about \$188,000. Finally, QRG Capital Management Inc. bought a new position in shares of **Ecopetrol** in the third quarter worth approximately \$228,000.

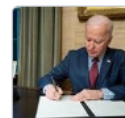

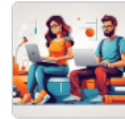

EC stock opened at \$7.92 on Wednesday. **Ecopetrol** S.A. has a one year low of \$7.21 and a one year high of \$12.90. Ecopetrol SA operates as an integrated energy company. The company operates through four segments: Exploration and Production; Transport and Logistics; Refining, Petrochemical and Biofuels; and Electric Power Transmission and Toll Roads Concessions. It engages in the exploration and production of oil and gas; transportation of crude oil, motor fuels, fuel oil, and other refined products, including diesel, jet, and biofuels; processing and refining crude oil; distribution of natural gas and LPG; sale of refined and petrochemical products; supplying of electric power transmission services; design, development, construction, operation, and maintenance of road and energy infrastructure projects; and supplying of information technology and telecommunications services.

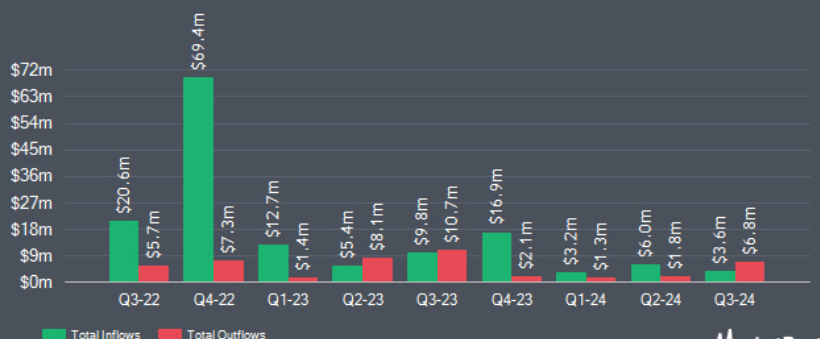

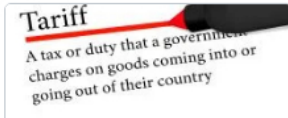
