Shares of [EC stock](#) opened at \$9.93 on Friday. The business has a 50 day simple moving average of \$9.24 and a 200 day simple moving average of \$8.75. The company has a debt-to-equity ratio of 1.00, a current ratio of 1.68 and a quick ratio of 1.38. The firm has a market capitalization of \$20.40 billion, a price-to-earnings ratio of 4.75 and a beta of 1.22. [Ecopetrol](#) S.A. has a 12-month low of \$7.21 and a 12-month high of \$12.90.

WALL STREET ANALYST WEIGH IN

EC has been the topic of a number of research reports. [StockNews.com](#) upgraded [Ecopetrol](#) from a "hold" rating to a "buy" rating in a research report on Friday. Citigroup upgraded [Ecopetrol](#) from a "neutral" rating to a "buy" rating and increased their price target for the stock from \$9.00 to \$14.00 in a research report on Tuesday, February 18th. Finally, JPMorgan Chase & Co. upgraded [Ecopetrol](#) from an "underweight" rating to a "neutral" rating and increased their price target for the stock from \$7.50 to \$9.50 in a research report on Thursday, February 13th. One analyst has rated the stock with a sell rating, two have issued a hold rating and two have issued a buy rating to the company's stock. Based on data from MarketBeat, the company presently has an average rating of "Hold" and a consensus price target of \$11.00.

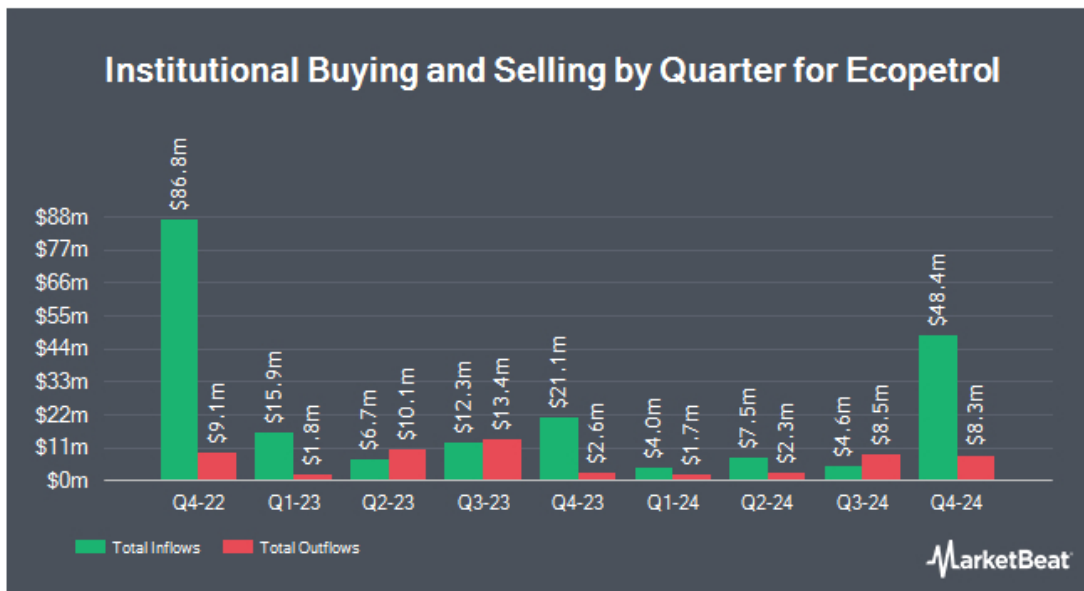

It engages in the exploration and production of oil and gas; transportation of crude oil, motor fuels, fuel oil, and other refined products, including diesel, jet, and biofuels; processing and refining crude oil; distribution of natural gas and LPG; sale of refined and petrochemical products; supplying of electric power transmission services; design, development, construction, operation, and maintenance of road and energy infrastructure projects; and supplying of information technology and telecommunications services.
