[Ecopetrol](#) S.A. is the largest company in Colombia and one of the main integrated energy companies in the Americas, employing more than 19,000 people. Domestically, it accounts for over 60% of the country's hydrocarbon production and operates most of the transportation, logistics and refining systems, while also holding leading positions in petrochemicals and gas distribution. Following its acquisition of 51.4% of ISA, [Ecopetrol](#) expanded into energy transmission, real-time systems management and road concessions in Colombia, and, through ISA and its subsidiaries, has become a major player in power transmission in Brazil, Chile, Peru and Bolivia, as well as in road concessions in Chile and the telecommunications sector. Internationally, the company has strategic exploration and drilling operations in the United States (Permian Basin and Gulf of Mexico), Brazil and Mexico.
